## **FMI/NCE – BOB QUINN CAMP REGULATIONS**

**Camp rules are designed to ensure a safe, pleasant and comfortable environment for all in the camp. Violation of the rules will result in consequences that may include discipline, removal of camp privileges and/or removal from the Bob Quinn work site.**

**Bob Quinn Camp is designated alcohol/drug free and Non Smoking facilities. Smoking is only permitted in designated outside areas.**

**All issues are to be brought to the attention of the FMI/NCE Construction Managers.**

1. Occupants of the camp shall show consideration for their neighbours in respect to the playing of radios or television sets, or noisy conversation after 10:30pm.
2. Late night parties in rooms that disturb other occupants of the camp are prohibited.
3. No occupant of the camp shall utilize laundry facilities that are located in the same building as the living quarters after 10:00pm.
4. You are financially responsible for any damages to your room. You must report any problems or damages to your room or common areas immediately.
5. No littering - garbage and recycling containers are to be used. This includes not leaving opened food items out on counters or stove tops, etc. in order to avoid attracting wildlife. Accommodations will be subject to weekly random inspections (with shop steward present) to ensure housekeeping standards are maintained.
