1. JURISDICTIONAL COMMENTS

The handling of jurisdiction, and jurisdictional disputes on this project is the sole responsibility of the labour relations department. No superintendent, supervisor, general foreman or foreman shall make or attempt to make any jurisdictional assignments. Any assignment made by anyone other than the labour relations department is null and void and of no effect on this project. Notwithstanding the above, FCCL recognizes and will adhere to the Jurisdictional Assignment Plan of the BC Construction Industry.

This includes the Final Assignments issued April 2020 for Early Works. Any discrepancy between previous markup awards and this markup award shall be determined by this Final Mark up.

- I. The fabrication, assembly, and installation of all pipe hangers, pipe supporting straps, saddles, roller type supports, U-bolts, clamps, knee supports, or other devices designed for the sole purpose of supporting pipe is the work of the UA.
- II. Free standing pipe supports (not tied together) for the sole purpose of supporting pipe will be the work of the UA.
- III. Free standing electrical supports (not tied together) for the sole purpose of supporting electrical conduit, cable, wire, tray, bus, duct, etc. shall be the work of the I.B.E.W.
- IV. Free standing supports (not tied together) and other supports for the purpose of supporting electrical and piping will be as per the UA/IBEW Agreement.
- V. Pipe supports attached to vessels, tanks and stacks is as per UA/Boilermaker agreement.
- VI. Multi-leg/bridge and truss type supports is the work of the Ironworker.

I. Catwalks, Platforms, Stairways and Ladders

- I. Catwalks, platforms, stairways, and ladders erected on, or in association with, storage tanks, columns and vessels shall be erected in accordance with the Boilermakers Ironworker Agreement (23 September 1953).
- II. The Ironworkers shall erect catwalks, platforms, stairways, and ladders supported by structural steel supports. When supported by a combination of the ground, the tank and/or structural steel supports, the erection of catwalks, platforms, stairways, and ladders shall be the work of the Ironworkers.
- III. The Boilermakers shall perform all welding directly to the outer surface of the tank, bins or hoppers erected by Boilermakers.
- IV. The Ironworkers shall erect catwalks, platforms, stairways, and ladders supported by and on vessels and other equipment erected by the Pipe Fitters.
- V. Catwalks, ladders, and platforms installed on and completely supported by tanks installed by Pipe Fitters is the work of the Boilermakers.

J. Catwalk, Checker Plate & Grating Modification

- I. Repairing and/or alterations to the catwalks, grating, checker plate, handrails, stairs, toe plates, ladders, etc., installed by the Ironworkers, shall be the work of the Ironworkers.
- II. Repairing and/or alterations to catwalks, grating, checker plate, handrails, stairs, toe plates, ladders, etc., installed by the Boilermakers, shall be the work of the Boilermakers.
- III. The layout and cutting of openings in metal gratings, metal floor plates and decks shall be by the craft desiring the right-of-way.
- IV. The installation of pipe sleeves intended as a guide or a device to hold the pipe in line or for the purpose as pipe support is assigned to the UA.
- V. Where a guide or device to hold the pipe in line or for the purpose as a pipe support the Ironworker or Boilermaker shall install the toe plate, depending on which trade has jurisdiction on the metal grating, and the UA shall return to complete the support.
- VI. Where a guide or device to hold electrical material in line or for the purpose as an electrical support the Ironworker or Boilermaker shall install the toe plate, depending on which trade has jurisdiction on the metal grating, and the IBEW shall return to complete the support.
- VII. In operational plants where safety requirements dictate that grating, checker plate etc, must be removed and remodeled in a safe work area. The removal, repair and re-installation shall be the work of the trade installing the grating. Reference items 1 and 2.

K. Blinding

I. As per UA/BM Agreement Info 67

- a) When tanks and/or vessels require blinding, the following guidelines will be used:
 - I. When blank or blind flanges are installed on vessels or tanks for the purpose of testing the vessel or tank, the work is Boilermaker.
 - II. When blank or blind flanges are permanently installed on vessels or tanks, the work is UA.

- III. When blank or blind flanges are installed on openings of tanks or vessels for future piping, the work is UA.
- IV. When blind flanges are installed and secured for the purpose of testing tanks, vessels, exchangers, and related equipment with inlet and outlet piping installed, such work is the Boilermaker.
- V. The removal of the blind flange and securing the joint after testing tanks, vessels, exchangers, and related equipment with inlet and outlet piping installed is the work of the UA.
- VI. It is understood that the trade whose safety is to be protected performs the blinding.
- b) When Boilermakers are working in the vessels, tanks, exchangers, and related equipment, they will install the blind flange to protect their members.
- c) When the UA are working in vessels, tanks, exchangers, and related equipment, they will install the blind flange to protect their members.
- d) When the work is completed, the removal of the safety blind flanges and sealing the piping system is the work of the UA.

- I. The following work is assigned to the Ironworker:
 - a) "First Drop" rights on all material/equipment offloaded by crane except for that described as follows:

 - a) Unloading and handling, regardless of means, of all pipe materials/equipment, including prefabricated pipe formations.
 - b) Unloading and handling, regardless of means, of piping materials, U.A. fabricated material and equipment assigned to the U.A.

- III. The Boilermaker shall unload and handle all items within their jurisdiction.
- IV. In accordance with the Agreement reached between the UA and the Boilermakers, the following shall apply:
 - a) Unloading, handling, and setting of completed condensers (shell and tube type), is the work of the UA.

Unloading, handling and erection of knockdown condensers (shell and tube type), is the workof the Boilermakers. When the condenser arrives on the jobsite with the head and box removed for shipping purposes, it shall be considered a completed condenser, the handling and setting of which shall be the work of the UA. The attaching of head and box shall be thework of the Boilermakers.

NOTE: This understanding reached between the UA and the Boilermakers does not changeor amend the assignment made on "power equipment, unloading and handling of piping material and equipment".

O. Instrumentation

- I. All work shall be executed in accordance with UA/IBEW MOU April 7, 1976
- II. The inspection and/or calibration of the instrument will be done by the respective craft having jurisdiction over the instrument.
- III. The installation of instruments and/or controls that utilize a piping connection directly to a piping system, or vessel, for the purpose of reacting to the variable characteristics of liquids, gases, or solids, shall be the work of the UA.
- IV. The installation of instruments and/or controls that utilize an electrical connection or electronic signal for the purpose of reacting to the variable characteristics of liquids, gases, or solids, shall be the work of the International Brotherhood of Electrical Workers.

- V. The installation of instruments and/or controls that utilize both a piping connection and an electrical connection shall be performed in the following sequence:
 - a) The UA shall mount in place the instrument and/or control, and complete the piping connection to the piping system, or vessel.
 - b) The International Brotherhood of Electrical Workers shall complete the electrical work necessary to make the instrument or control operable.
 - c) If any instrument or control removal is necessary, the sequence shall be reversed for the removal, and reinstituted at the time of the subsequent installation.
- VI. The fabrication and installation of brackets or supports necessary for the above installation shall be the work of the craft installing the instrument or control.
- VII. Loop checks that involve completely pneumatic loops shall be performed by the UA.
- VIII. Continuity checks that involve electronic loops with no tie-in to a piping system shall be performed by the International Brotherhood of Electrical Workers.
 - IX. Loops that involve combination of pneumatic and electronic signals, including calibration of instruments, shall be performed by the UA and the International Brotherhood of Electrical Workers in a sufficient number to maintain craft jurisdiction

- I. All work shall be in accordance with UA/MW Agreement October 6, 1964 and UA/BM Agreement Info 67
- II. Filters within the initial receiving system and prior to commencement of process are the work of the U.A.
- III. Once it is determined that process has commenced, all filters that are inline (i.e. Supported by the pipeline) are the work of the U.A.
- IV. Once it is determined that process has commenced, all filters, other than inline filters, shall be installed on composite basis by equal numbers of members of the U.A. and the Boilermakers.
- V. Filters not within the process system, for instance lube oil systems or water systems, are the work of the U.A.

Q. Pumps and Compressors

- I. In accordance with the UA/MW Agreement October 6, 1964
- Preassembled (completed)
 - a) The unloading and handling of pumps, compressors and their bases and placing on their foundations are the work of the UA.
 - b) Levelling to piping elevation of preassembled pumps and compressors and their bases is the work of the UA. In cases where further levelling and aligning is unnecessary, permanent securing is to be performed by the UA.
 - c) Where precision levelling and aligning is required after pump and compressor is raised to piping elevation, said levelling and aligning and permanent securing shall be by the Millwrights.
 - d) Reduction gearboxes, fluid drives, speed increasers, or any driving mechanism to be connected to the pumps or compressors shall be unloaded, handled, installed, aligned and levelled by the Millwrights.
- II. Disassembled (knocked-down)
 - a) The unloading, handling, assembling, aligning, and levelling of disassembled pumps, compressors, component parts and bases is the work of the Millwrights.
 - b) Reduction gearboxes, fluid drives, speed increasers, or any driving mechanism to be connected to the pumps or compressors shall be unloaded, handled, installed, aligned and levelled by the Millwrights.
 - c) The United Association shall provide the Millwrights with rigging assistance.
 - d) Electrical motors will be unloaded, handled, and set in accordance with MW/IBEW Agreement June 1, 1963

R. Pumps/Compressor Bases

- I. All work shall be executed in accordance with UA/MW Agreement October 6, 1964
- II. The Millwrights shall do precision aligning or levelling of bases shipped separately from the pumps and compressors.
- III. When it is necessary to attach pumps or compressors to bases that are shipped separately, in order to bring them to piping elevation, the UA shall do such work.
- IV. The Millwrights shall do fabrication, alteration, drilling, taping and/or dwelling of such bases.
 - a) The United Association shall provide the Millwrights with power rigging assistance.

- d. Unions will have 3 business days to submit evidence.
- e. FCCL will make a final award within 48 hrs
